### The Really Good News...

The book If It Works, Don't Fix It: What Every Man Should Know Before Having A Vasectomy by Kevin Hauber is finally available from the publisher in printed form. This has been a long-awaited event, and will help to make information available to those persons debating whether or not to have the procedure as well as those already experiencing pain and problems because of their vasectomies.

### **And the Bad News...**

Kevin's lawsuit against the urologist who did his original vasectomy was withdrawn from court without compensation at the end of 2003. In the three-and-a-half years the case floundered in the court system, an Appellate Court in California came down with a ruling changing the rules of evidence in the case.

The new standard set would require a urologist in the local area to testify in court that failing to disclose the possibility of causing significant nerve damage or other injury leading to post-vasectomy pain syndrome is beneath a normal standard of care in presenting and performing the procedure. While this is no great stretch of the imagination for us normal folk, the fact of the matter was that no urologist would offer this testimony. Several of the doctors who had previously offered opinions in this regard backed out as the trial approached. Interestingly, many of them had the same malpractice insurance company (and lawyer) as the urologist being sued.

Other men have reported similar outcomes from their attempts at litigation to aid them through post-vasectomy woes and expenses. The situation is a very difficult one. With the strangle hold that the insurance companies and the medical profession have on the legal system, recourse for even gross errors is limited.

The moral of the story is that when you go to a doctor and take any drug prescribed, or undergo any surgery or other form of treatment, you are doing so at your own risk, and are quite literally putting your life in the doctor's hands. Consider that the next time some significant medical treatment is recommended. *You, not the doctor*, get to live with the outcome, even if the procedure is "simple," as vasectomy is commonly claimed to be.
